This research is important **because it addresses a significant social issue and fills gaps in the literature regarding immigrant integration in Canada.** Despite the existence of various settlement programs, immigrants still face challenges in fully integrating into Canadian society. By identifying these challenges, the research contributes to a better understanding of the complexities surrounding immigrant integration and informs the development of more effective programs and policies to support immigrants in becoming active members of their new communities.

Key Findings

The study uncovered significant insights into the experiences of immigrants in Canada. Participants emphasized the need for safety, respect, and cultural comfort, while highlighting challenges such as language barriers affecting social connections and employment opportunities. Understanding these complexities is essential for developing targeted support systems to enhance immigrant well-being and integration into Canadian society.

- **Settlement Journey and Housing Choice:** Participants considered factors like noise, traffic, and family connections when choosing where to live in Canada. One participant stated, "Relocated to Milton from Mississauga seeking a quieter environment with less traffic and lower living costs."
- **Motivation for Immigration:** Various motivations for immigrating to Canada were identified, including escaping conflict, family connections, and fulfilling dreams. As one participant expressed, "Came to Canada to escape conflict in Syria, dreamt of living in Canada."
- **Sense of Belonging:** Immigrants associated belonging with feelings of safety, comfort, and inclusivity. A participant articulated this sentiment, saying, "For me it is the roots in the earth because I love my family to stay together and to be rooted in the ground."
- **Cultural Differences:** Participants noted differences between their home societies and Canadian society, particularly regarding family relationships and women's rights. One participant mentioned, "Women have more rights, but raising children back home is better than in Canada."
- **Language Barrier and Integration:** Language emerged as a significant barrier to integration, affecting social connections and employment opportunities. A participant shared, "I am not fully integrated because I do not have any relationship with the Canadians. I have no friends due to the language barrier."

Discussion

The study's findings largely align with existing literature on immigrant integration, confirming established themes such as housing choice, motivations for immigration, sense of belonging, cultural differences, language barriers, and attitudes toward diversity. However, the study adds unique value by providing **firsthand immigrant perspectives**, offering depth and authenticity to the research. Through participant interviews and quoted experiences, it delves into nuanced aspects of the settlement journey, such as **the influence of family connections on housing choices** and the **intersectionality of language barriers with social integration**. Overall, the study contributes depth and insight to existing knowledge, providing researchers and policymakers with a richer understanding of immigrant experiences in Canada.

Implications for policy and/or practice

The study's implications for practitioners and policymakers are significant. They include the need for tailored support programs informed by insights into factors **influencing housing choices, prioritization of language and employment services to address language barriers, cultural sensitivity training for practitioners, promotion of community engagement initiatives to foster social connections, and development of inclusive policies that address systemic barriers and are accessible to all immigrants.** These implications underscore the importance of holistic and culturally sensitive approaches to immigrant integration, emphasizing collaboration between stakeholders to support successful settlement outcomes.

Methods

- **Methodology:** Qualitative. This qualitative methodology aligns with the research purpose of gaining a comprehensive understanding of immigrants' experiences and perspectives.
- **Data Collection:** one-on-one interviews, which allowed for in-depth exploration of participants' experiences, feelings, and opinions and questionnaires which supplemented the interviews, providing additional insights and allowing for a broader range of responses. Personal observation added context and depth to the study, providing insights into immigrants' daily lives and interactions within their communities. **Interviews were conducted in both Arabic and English**, and then were transcribed and translated.
- **Participants:** The participants in this research are **adult and senior newcomers in Ontario, Canada**, recruited through organizations funded by IRCC (Immigration, Refugees, and Citizenship Canada). Snowball sampling was employed to recruit participants, allowing for the inclusion of immigrants from diverse backgrounds and experiences.
- **Data Analysis:** Transcribing and translating interviews conducted with recent immigrants from Arabic to English. Thematic analysis was then employed to identify recurring patterns and themes within the data. Through systematic coding and organization of the transcripts, key concepts and ideas emerged, reflecting the experiences and perspectives of the participants. **Member checking was used to validate the accuracy of the analysis.** Overall, the analysis aimed to uncover insights into the integration experiences of recent immigrants, providing valuable information for future research and interventions.
- **Ethical Considerations:** By prioritizing participant confidentiality through measures like confidentiality agreements and anonymous questionnaires, the research ensured that immigrants feel safe sharing their experiences without fear of privacy breaches. This was crucial for fostering trust and obtaining candid insights into their integration challenges. Additionally, the emphasis on data accuracy and integrity aligned with the research's goal of providing reliable findings to inform policies and interventions aimed at improving immigrant integration. Addressing potential conflicts of interest, such as the researcher's role in the participants' community, underscored the commitment to impartiality and transparency in the research process.
